UMANA CHAPTER NEWS

PENNSYLVANIA BRANCH met for their yearly meeting on December 3, 2022, at Maggiano's Little Italy. A certificate of honor was presented to **Dr. Oksana Baltarowich**, for her long-time work for the Ukrainian community, the medical profession, and UMANA. **Dr. Ihor Rak** presented his project "Coaching and Mentoring Professionals on a pro bono basis"; afterwards, the Board accepted the proposal to engage in his project and invite UMANA members at large to participate.



New Chapter leaders were also elected: President – Mark Shust, OD; Vice-President – Yuriy Shevtsiv, MD; Secretary – Victoria Shust, OD; Treasurer – Oksana Baltarowich, MD; Board members – Ihor Rak, MD, and Ihor Fedoriw, OD.

OHIO BRANCH continued their partnering with United Ukrainian Organizations of Ohio, MedWish International, ReLink International and other northeastern Ohio Ukrainian community organizations to provide medical and humanitarian aid for Ukraine. Adding to previous shipments, they have sent: 21 pallets of medical supplies; hundreds of lifesaving IFAKs and Quikclots to soldiers on the frontlines; 250 military grade Gen-7 one-handed CAT tourniquets and preparing more; 14 CPR and intubation mannequins for training first responders, and other needed supplies.

President's Message

When I was in grade school, one of my classmates asked me, "What country is your family from?" I remember explaining that my family was originally from Ukraine. Then I showed him where Ukraine was on the map, and said, "That's where we're from – Ukraine." The kid called me "a commie!" Of course, I explained that our family is here in the U.S. precisely because we want nothing to do with the USSR. I told him, "We are the farthest thing from commies!"

From the start of the Russian invasion, medical societies have been faced with the dilemma of how to respond. Should they make statements condemning the war? In the case of international societies, should they ban citizens of Russia from participating in meetings?

In recent weeks, there have been debates about banning Russian athletes from the Olympics. Is it fair that they should be punished just because their government is evil?

Well, the same way that a kid in grade school can renounce a country with which he doesn't want to be associated, so too can a member of an international medical society or an Olympic team. Rather than outright banning of Russian doctors from meetings or Russian athletes from the Olympics, organizational leadership could give them a formal statement of renunciation to sign.

The statement would state something like this:

"I, (name), citizen of the Russian Federation, support the United Nations General Assembly Resolution ES-11/1, which 'deplores in the strongest terms, the aggression by the Russian Federation against Ukraine,' which 'demands that the Russian Federation immediately cease its use of force against Ukraine' which 'demands that the Russian Federation immediately, completely, and unconditionally withdraw all of its military forces from the territory of Ukraine within its internationally recognized borders,' and which was passed on March 2, 2022 by a vote of 141-5."

It would take some courage for a medical society or the International Olympic Committee to require such an attestation, and it would take courage for the Russian doctor or athlete to sign it, but that pales in comparison with the courage of the Ukrainian medics and athletes, some of whom have lost their limbs or their lives. They did so, honoring the words of the Ukrainian national anthem: "Our bodies and our souls, we'll lay down for our freedom!"

And "That's where we're from – Ukraine."
